UNFINISHED BUSINESS

A motion was made by Mr. McLinko, seconded by Mr. Smith all voted “aye” to approving the Minutes of April 1, 2010.

NEW BUSINESS

A motion was made by Mr. McLinko, seconded by Mr. Smith, all voted “aye” to approving an Intergovernmental Cooperative Agreement under Title IV-D of the Social Security Act between PA Department of Public Welfare, Domestic Relations Section of the Court of Common Pleas and the Bradford County Commissioners, for the period 10/1/10 through 9/30/15.

A motion was made by Mr. McLinko, seconded by Mr. Smith, all voted “aye” to proclaiming the week of April 18 – 24, 2010 as “National Crime Victims Right Week” in Bradford County.



A motion was made by Mr. McLinko, seconded by Mr. Smith, all voted “aye” to acceptance of the Bradford County Juvenile Accountability Court grant from PA Commission on Crime and Delinquency in the amount of \$10,000 for the period 4/1/2010 – 3/31/2011. This grant is being used for repeat juvenile offenders who have been unsuccessful on standard probation and are at risk of being removed from home.

A motion was made by Mr. McLinko, seconded by Mr. Smith, all voted "aye" to submission of the CJAB grant application to PA Commission on Crime and Delinquency in the amount of \$34,328 for the period 7/01/10 through 6/30/11.

A motion was made by Mr. McLinko, seconded by Mr. Smith, all voted "aye" to approving an Amendment between Bradford County Human Services and Allied Services for the period July 1, 2009 to December 31, 2009. Service: Supported living for individuals with mental health. Rate Base supported living: rate remains at \$18.50/15 minute unit. Contract total remains at \$56,875. CHIPP's supported living: Rate adjustment from \$20.00/15 minute unit to \$25.90 per 15-minute unit for the period July 1, 2009 through December 31, 2009. Contract total for this period will remain at \$70,000.
