# LIVING WITH FLOODS

In 2006 Endless Mountains RC&D Council set out to develop a program to enable municipal and other elected officials to become more pro-active to flooding. In 2007 and 2008 the Council and several partners planned and hosted 3 Flood Summits: at Keystone College, Trout Run Fire Hall and Wysox Fire Hall. These Summits were well attended by municipal officials, county officials/agencies, and Federal and state legislators. More than 58% of the municipalities in the 6 county region were represented.

As part of the Summits we provided Flood Toolboxes to each municipality and agency in attendance. These toolboxes contained resource information on Stormwater and Floodplain Management, Disaster Response, Hazard Mitigation, Stream and Watershed Management, and a host of other related resources including agency contact information and websites for additional information. In addition to the Flood Toolboxes presentations were given on a variety of stormwater and floodplain management topics. The afternoon sessions included roundtable discussions identifying barriers/issues decision-makers feel prevent them from becoming more pro-active. Several things were identified and have become the focus for this second round of Flood Summits. You asked for more education, tools to help make decisions, and usable floodplain maps.

By attending this workshop you should gain the tools you need to make a determination on what is and what is not an appropriate location to build a structure in or near a floodplain.
